Council adopts 2021 - 2025 Financial Plan

Property taxes are one of the ways the Town collects revenue to pay for Town services. The amount you pay is based on the funds the Town needs to provide Town services each year. These Town services include Police, Fire Rescue, Development, Building services, Roads, Storm Drains, Parks, Recreation, and current and future infrastructure replacement.


Council approved a residential property tax increase of 4.95% which was much lower than the 9.3% required, due to increases in RCMP costs. This increase reflects overall rising costs and an increased bill for policing. Municipalities with populations from 5,000 to 14,999 pay 70% of the RCMP policing cost as per the agreement with the Province. The Town's share of costs will rise to 90% (approx. \$500,000 more) as the Town crosses the 15,000 population mark in the 2021 Census. Council was able to do this through the use of funds in the public safety reserve which were set aside for this purpose and the COVID-19 Safe Restart grant.

Please be aware that the Town of Comox does not control the levies from other taxing authorities that appear on your tax notice (Schools, Hospital, Library, Regional District, BC Assessment Authority, and Municipal Finance Authority). The Other Taxing Authorities account for 55% of property-value tax on your Tax Notice.


In 2021, for properties with water meters, the maximum allowable usage has been reduced to 471 cubic-metres (m3), and for 2022 it will be 450 m3 as per consolidated Bylaw 529. Above the limit, flat rate users will pay \$1.63 per m3, and metered customers will pay \$1.60 per m3.





Other Agency property taxes are collected for the Province of B.C., the Regional District, Hospital District, Vancouver Island Regional Library, BC Assessment and Municipal Finance Authority. The Regional District provides 18 services to the Town, including recreation facilities, exhibition grounds, public transit, solid waste disposal, 911 response, community justice and search & rescue. The Hospital District provides capital funding for new health care facilities and equipment.
