EXECUTIVE SUMMARY

Pinchin Ltd. (Pinchin) was retained on June 15, 2023 through an Authorization to Proceed, Limit of Liability and Terms of Engagement signed by Laubenfels Development Advisors for Avtar Properties Management Corp. (Client) to conduct a Phase I Environmental Site Assessment (ESA) of the vacant portion of the property located at 1966 Guthrie Road, Comox, British Columbia (BC) (hereafter referred to as the Site).

The Site is vacant land, free of any permanent structures and/or buildings.

Pinchin was advised by the Client that the purpose of the Phase I ESA was to assess potential issues of environmental concern in relation to the potential refinancing of the Site.

The Phase I ESA was completed in general accordance with the Canadian Standards Association (CSA) document entitled "Phase I Environmental Site Assessment, CSA Standard Z768-01" dated November 2001 (reaffirmed 2022) and the general requirements of the BC Contaminated Sites Regulation (CSR), including a review of readily-available historical records, a review of readily-accessible regulatory records, a Site reconnaissance, interviews, an evaluation of information and reporting, subject to the limitations outlined in Section 8.0 of this report.

Based on the results of the Phase I ESA completed by Pinchin, nothing was identified that is likely to result in potential subsurface impacts at the Site. As such, no subsurface investigation work (Phase II ESA) is recommended at this time.

This Executive Summary is subject to the same standard limitations as contained in the report and must be read in conjunction with the entire report.

1.0 INTRODUCTION

1.1 **Background**

Pinchin Ltd. (Pinchin) was retained on June 15, 2023 through an Authorization to Proceed, Limit of Liability and Terms of Engagement signed by Laubenfels Development Advisors for Avtar Properties Management Corp. (Client) to conduct a Phase I Environmental Site Assessment (ESA) of the vacant portion of the property located at 1966 Guthrie Road, Comox, British Columbia (BC) (hereafter referred to as the Site).

The Site is vacant land, free of any permanent structures and/or buildings.

Pinchin was advised by the Client that the purpose of the Phase I ESA was to assess potential issues of environmental concern in relation to the potential refinancing of the Site.

1.2 Scope of Work

The Phase I ESA was completed in general accordance with the Canadian Standards Association (CSA) document entitled "Phase I Environmental Site Assessment, CSA Standard Z768-01" dated November 2001 (reaffirmed 2022) and the general requirements of the BC Contaminated Sites Regulation (CSR), including a review of readily available historical and regulatory records, a Site reconnaissance, interviews, an evaluation of information and reporting, all subject to the limitations outlined in Section 8.0 of this report.

Pinchin conducted a Site reconnaissance on June 23, 2023, and was unaccompanied at the time.

In addition, Pinchin reviewed the document entitled FINAL Phase I Environmental Site Assessment, 1966 Guthrie Road, Comox, British Columbia", prepared by Pinchin Ltd. for 1092027 BC Ltd. and dated October 19, 2016 (2016 Pinchin Phase I ESA Report).

SITE DESCRIPTION 2.0

2.1 **Site Location and Physical Description**

As indicated on Figure 1 (Key Map), the Site is located on the north of Guthrie Road, approximately 130 metres west of Anderton Road in Comox, BC. The Site is situated in an area that predominantly consists of residential, commercial and agricultural land uses. Figure 2 illustrates the Site and surrounding area.

A summary of the physical description of the Site is provided below:

2.3 Site Operations

The Site consists of a vacant vegetated lot, with no buildings or permanent structures.

Further details regarding on-Site operations are provided in Section 5.0.

3.0 HISTORICAL RECORDS REVIEW

3.1 Site Interviews and Records

There was no Site Representative available at the time of the Site reconnaissance.

3.2 Aerial Photographs and Satellite Imagery

Copies of aerial photographs dated 1950, 1957, 1964, 1975, 1984, 1992 and 1996 were obtained from the University of British Columbia (UBC) Geographic Information Centre (GIC) in Vancouver, BC and reviewed by Pinchin.

In addition, Pinchin reviewed Google Earth™ satellite imagery dated 1985, 2003, 2004, 2005, 2012, 2015, 2016, 2017, 2018, 2019 2020, 2021 and 2022.

It should be noted that accurate details could not be determined from the 1985 and 1996 aerial photographs due to the large reference scale and the low resolution of the photographs.

An RFO with associated underground storage tanks (USTs) appeared to be located approximately 150 m southwest of the Site with USTs approximately 160 m west-southwest of the Site and are situated

hydraulically up/transgradient of the Site relative to the inferred groundwater flow direction. Based on the distance between the Site and the RFO, it is Pinchin's opinion that is it unlikely to result in potential subsurface impacts at the Site.

Based on Pinchin's review of the aerial photographs and satellite images, nothing was observed that is likely to result in potential subsurface impacts at the Site.

3.3 Fire Insurance Plan

The Catalogue of Canadian Fire Insurance Plans (FIPs) 1875-1975 does not list the Site or surrounding area. Therefore, no FIPs could be obtained for review.

3.4 **City Directories**

City directories for the years 1965 to 2000 were reviewed by Pinchin at the Vancouver Public Library in Vancouver, British Columbia. It should be noted that no city directories were available for the Town of Comox subsequent to 2000. A summary of information obtained with respect to the Site is provided in the following table:

In general, the city directories indicated that the surrounding area has historically consisted of residential, commercial and agricultural land uses since 1965. No historical dry-cleaning operations, RFOs or other operations of potential environmental concern were identified; however, Pinchin notes the following:

- Hilo Transportation Ltd., bus charters, ski buses and day tours was listed at 750 Anderton Road in 1993. This property is located approximately 50 m west of the Site and is situated hydraulically up/transgradient to the Site relative to the inferred groundwater flow direction. Based on a review of aerial photographs, this was inferred to be a small-scale operation. Based on this information, as well as the short duration of operations, it is Pinchin's opinion that the historical bus charger operations are unlikely to result in potential subsurface impacts to the Site;
- An automotive repair/servicing facility was listed at 678 Anderton Road in 2000. This property is located approximately 100 m southwest of the Site and is situated hydraulically upgradient of the Site relative to the inferred groundwater flow direction. Based on the distance between the automotive repair/servicing facility and the Site, it is

- Longland R E Trucking Ltd. was listed at 701 Anderton Road from 1975 until 1996, and a RFO was listed at this property in 2000. This property is located approximately 150 m west-southwest of the Site and is situated hydraulically up/transgradient of the Site relative to the inferred groundwater flow direction. Based on the distance between this property and the Site, it is Pinchin's opinion that this off-Site operation is unlikely to result in potential subsurface impacts at the Site; and
- Historical or current RFOs, automotive repair facilities and dry cleaners were listed within the city directories reviewed for the Site area. However, based on the distance of these facilities from the Site, as well as the inferred groundwater flow direction, it is Pinchin's opinion that these historical or current facilities are unlikely to result in potential subsurface impacts at the Site.

3.5 Land Title

A copy of the current land title was obtained by Pinchin from the BC Land Title and Survey Authority (BC LTSA). Based on information obtained from the BC LTSA, the Site is described as "Lot A; Section 77; Comox District; Plan VIP86498". The land title indicated that "ACI Comox Investments Ltd." was listed as the registered owner of the Site at the time of this assessment. No liens or other encumbrances indicating potential environmental concern were noted within the current title.

A copy of the current land title is included in Appendix I.

3.6 Previous Environmental Reports

2016 Pinchin Phase I ESA Report

The Phase I ESA completed by Pinchin in October 2016 consisted of historical reviews, a review of surrounding properties, a regulatory database search, and interviews as well as an exterior assessment of the Site. As part of the 2016 Pinchin Phase I ESA, Pinchin reviewed the following document:

 "Stage I Preliminary Site Investigation, 762 and 750 Anderton Road and 1984, 1966 and 1940 Guthrie Road, Comox, British Columbia", prepared by EBA Engineering Consultants Ltd. For ACI Comox Ltd. and dated September 2006.

The results of the 2016 Pinchin Phase I ESA Report indicated that there were no significant potential environmental concerns associated with the current and historical use of the Site and adjacent properties and as such, no further environmental assessment work was recommended

3.7 **Historical Summary**

Based on the results of the historical review, nothing was identified that is likely to result in potential subsurface impacts at the Site.

4.0 REGULATORY INFORMATION AND CORRESPONDENCE

Laubenfels Development Advisors for Avtar Properties Management Corp.

4.1 **Site Regulatory Information**

Pinchin requested copies of permits, approvals and registrations from the Client and was advised that there is no regulatory information with respect to the Site.

4.2 **Local and Municipal Government**

Pinchin contacted Comox Fire Rescue to request records pertaining to the installation or removal of USTs on the Site. It was reported to Pinchin that the Comox Fire Rescue does not keep records of USTs for properties in Comox.

4.3 Ministry of Environment and Climate Change Strategy Water Resource Atlas

A search of the existing wells in the area on the BC Ministry of Environment and Climate Change Strategy (ENV) Water Resource Atlas well database indicated that there were 28 wells of unknown use located within a 500 m radius of the Site. One of these wells were potentially located on-Site (Well Tag # 12334,). This well was constructed in 1950. The search results are located in Appendix II.

Pinchin observed three wells on-Site with metal covering. Additionally, Pinchin observed four plastic covered wells at the southeast corner of the Site, approximately 5 m from the south boundary. Pinchin also observed seven wells at the southeast corner of the Site on a concrete pad, approximately 2 m from the south boundary. The seven wells on the concrete pad were observed to be uncovered.

4.4 ERIS and BC Ministry of Environment and Climate Change Strategy Site Registry

Pinchin submitted a request to Environmental Risk Information Service Ltd. (ERIS) for a review of the following databases, as they pertain to the Site and surrounding properties:

- "Contaminated Sites on Federal Land":

A copy of the ERIS report is provided in Appendix III. Based on a review of the information obtained from the above-noted sources, Pinchin notes the following:

- The Site was not listed in any of the above-noted databases reviewed by Pinchin;
- The property located at Unit 17; 1957 Guthrie Road was listed in the Waste Generators Summary (GEN) database (BCG103304) for the generation of asbestos in 2022. Pinchin infers that this waste was generated during renovation activities at this property. This property is located 30 m south of the Site and is situated hydraulically trans/upgradient of the Site relative to the inferred groundwater flow direction. Based on the distance between this property and the Site, as well as the nature of waste generated, it is Pinchin's opinion that this property is unlikely to result in potential subsurface impacts at the Site:
- The intersection of Anderton Street and Guthrie Road was listed in the Site Registry (SREG) database (Site ID 15387). A Notice of Independent Remediation Completion was submitted to the ENV in 2013. This property is classified as non-high risk. This property is located 120 m west-southwest of the Site and is situated hydraulically up/transgradient of the Site relative to the inferred groundwater flow direction. Based on the distance between this property and the Site, it is Pinchin's opinion that this property is unlikely to result in potential subsurface impacts at the Site;

The property located at 1-678 Anderton Road was listed in the Scott's Manufacturing Directory (SCT) for manufacturing activities including automotive trimmings, apparel findings and related products, and for commercial screen printing. This property is located 100 m southwest of the Site and is situated hydraulically upgradient of the Site relative to the inferred groundwater flow direction. Based on the distance between this property and the Site, it is Pinchin's opinion that this property is unlikely to result in potential subsurface impacts at the Site;

- The property located at 5-678 Anderton Road was listed in the SCT for manufacturing activities including pleating, decorative and novelty stitching and tucking for the trade, and for other textile product mills. This property is located 100 m southwest of the Site and is situated hydraulically upgradient of the Site relative to the inferred groundwater flow direction. Based on the distance between this property and the Site, it is Pinchin's opinion that this property is unlikely to result in potential subsurface impacts at the Site;
- The RFO located at 701 Anderton Road was listed in the SREG database (Site ID 3889). An internal review was requested for a Preliminary Site Investigation Report in 1997. A Request for Determination was also submitted and subsequently withdrawn in 1997. The property was also listed three times in the Retail Fuel Storage Tanks (RST) database as a service station for gasoline and natural gas. This property was also listed in the Generators Special Waste Information System (SWIS) (GEN2) database for the generation of oily water sludge/debris, ceramic beads, waste oil filter cake, aluminium and sand in 2012. This property is located approximately 150 m southwest of the Site, with UST and pump island located 160 m west-southwest of the Site, and is situated hydraulically up/transgradient of the Site relative to the inferred groundwater flow direction. Based on the distance between this property and the Site, it is Pinchin's opinion that this property is unlikely to result in potential subsurface impacts at the Site; and
- The remaining listing are located greater than 100 m from the Site and therefore do not warrant further discussion.

4.5 Regulatory Information Summary

Based on the regulatory information reviewed, nothing was identified that is likely to result in potential subsurface impacts at the Site.

5.0 SITE RECONNAISSANCE

Pinchin (see Appendix IV for assessor qualifications) conducted a Site reconnaissance on June 23, 2023, and was unaccompanied. The Site reconnaissance included a walk-through of accessible exterior areas

of the Site. At the time of the Site reconnaissance, the ground surface was dry and the weather was clear. The Site reconnaissance was documented with notes and photographs. The results of the Site reconnaissance are discussed below. Photographs of some of the features noted during the Site reconnaissance are attached in Appendix V.

5.1 Hazardous Materials

No spills or evidence of historical spills (i.e., staining) were observed at the time of the Site reconnaissance.

5.2 Storage Tanks

5.2.1 Aboveground Storage Tanks

No aboveground storage tanks (ASTs) were observed on-Site However, Pinchin was unaccompanied at the time of the Site reconnaissance. Therefore, a representative knowledgeable about the Site was not available to confirm or deny the presence of a former or current AST located at the Site. No evidence of former ASTs was observed by Pinchin.

5.2.2 Underground Storage Tanks

No evidence of USTs (i.e., fill/vent pipes) was observed on-Site. However, Pinchin was unaccompanied at the time of the Site reconnaissance. Therefore, a representative knowledgeable about the Site was not available to confirm or deny the presence of a former or current UST located at the Site. 5.4 **Hydraulic Equipment**

No evidence of hydraulic equipment (i.e., hydraulic hoists, elevators, compactors, dock levels, etc.) was identified at the Site during the Site reconnaissance.

5.5 **Polychlorinated Biphenyls**

The use of polychlorinated biphenyls (PCBs) in electrical equipment such as transformers, fluorescent lamp ballasts, and capacitors was common until Canada banned its use in 1980. The Federal PCB Regulations, SOR/2008-273, regulate the manufacture, import, export, sale, use and processing of PCBs. These regulations required the decommissioning of equipment containing high levels of PCBs (>500 ppm) in 2009. Additionally, the regulations require decommissioning of light ballasts, pole top transformers, capacitors and electrical equipment containing greater than 50 mg/kg PCBs by December 31, 2025. Cables, pipelines and equipment associated with natural gas, petroleum and petroleum products, and fusion sealed capacitors for use in communication equipment and electrical control equipment are exempt from the decommissioning requirement.

Given that the Site is currently vacant land with no permanent structures, it is unlikely that PCBs are present on-Site.

5.6 **Asbestos-Containing Materials**

Asbestos-containing materials (ACMs) are commonly found in building construction materials (particularly in older buildings). Asbestos use in building products declined in use starting in the 1970s, with the

majority of products being phased out by circa 1990. Asbestos use in Canada was formally banned in December 2018.

Friable asbestos (friable is defined as a material that can be crumbled, powdered or pulverized by hand pressure) was widely used in sprayed fireproofing until 1973, and in decorative or finishing plasters, and thermal systems insulation until the early 1980s. Non-friable or manufactured asbestos products were widely used in building construction including in vinyl floor tiles, sheet flooring, ceiling tiles, pipe gaskets, roofing materials, asbestos cement boards, and numerous other products until circa 1990. A limited number of non-friable asbestos products remained in use until the end of 2018; examples include friction materials, gaskets, cement pipes, sealants, adhesives and caulking.

Given that the Site is currently vacant land with no permanent structures, it is unlikely that ACMs are present on-Site. Pinchin did not conduct an asbestos survey as part of this Phase I ESA, nor was any destructive or intrusive sampling or inspection conducted as part of this Phase I ESA.

5.7 Lead-Containing Paints

Lead was commonly used as an additive in paints with no restricted level up until the mid-1970s. This included architectural paints used on interior and exterior surfaces, primers and coatings for anti-corrosive purposes, consumer paints, and paint on furniture and other household items. Beginning in 1976, the federal government limited the amount of lead in consumer paints to 5,000 parts per million (ppm) and steadily reduced the lead content, primarily in the interest of public safety. In 2005, the limit was reduced to 600 ppm and in 2010, the limit was further reduced to 90 ppm, however, there is no restriction on lead in paints used for anti-corrosion purposes (e.g., steel primers and exterior coatings) and road and line markings. In June 2016, these exemptions were removed and as of this date, any paint sold should not contain more than 90 ppm, even if sold for anti-corrosion purposes.

Given that the Site is currently vacant land with no permanent structures, it is unlikely that lead is present on-Site. Pinchin did not conduct an assessment of lead in painted surfaces as part of this Phase I ESA.

5.8 Ozone-Depleting Substances

The bulk storage of ozone-depleting substances (ODSs) was not observed at the time of the Site reconnaissance.

5.9 Radon

Radon is a naturally occurring radioactive gas formed by the breakdown of uranium in soil, rocks and even groundwater. Radon is invisible, odourless and colourless and as such, can only be detected with specific radiation-sensing equipment. Radon escapes from the ground and mixes with outdoor air forming concentrations that are too low to be of concern; however, if radon enters a building the concentrations

can increase to higher levels. Health Canada has developed guidelines for acceptable levels of radon in dwellings and public buildings and has indicated that radon levels should not exceed 200 Becquerels per cubic metre (Bq/m³). Testing for radon at the Site was beyond the scope of this Phase I ESA. The Site Client reported that no radon surveys have been carried out at the Site.

5.10 **Mould or Microbial Contamination**

The presence of mould or other microbiological contamination in buildings has become a concern to building tenants and owners due to potential health effects on occupants and users. Provincial Ministries of Labour have recently issued guidelines on enforced regulations to protect the health of construction workers who are exposed to mould in the course of building renovation. The presence of water leaks or high humidity can cause the growth or amplification of mould within building environments.

Given that the Site is currently vacant land with no permanent structures, indoor mould is not present on-Site.
