Comox Valley RCMP

Inspector Scott Mercer, Comox Valley RCMP, presented the RCMP Quarterly Report for July 1 - September 30, 2024. In the second quarter of the 2024-2025 fiscal year, the Comox Valley RCMP reported 677 Calls for Service in Comox, a 13% decrease from the previous year, with the most common call types being property-related, alarms, and missing persons, and an increase in violent crime and theft from vehicles.
