Call to Order:

The meeting was called to order at 5:00 p.m. with 17 members of the public in attendance.

a. Dayna Forsgren (Coalitions to End Homelessness) Grant-in-Aid Funding

Delegation - Coalitions to End Homelessness

The Comox Valley Coalition to End Homelessness, representing over 40 organizations, provided an update on recent work and funding. Support will go toward projects like Rainbow House, with youth involvement through Dawn to Dawn. The last homelessness count was 273, with updated data expected in the fall. Progress on housing and seniors' needs is slow but ongoing, requiring collective effort.

b. Jenny Steel (Comox Golf Club) - To seek support of an extension of the Lease

Comox Golf Club - Lease Extension

The Comox Golf Club delegation outlined challenges with the compact course layout, which prevents safe multipurpose use such as trails, and proposed limited community use in three designated "safe zones." They also requested support for a new 30+5 year lease to meet grant and financing requirements for irrigation upgrades and clubhouse renovations.

c. Michael Zbarsky (CVRD), David Holzer (BCAA): Update on Regional Electric Bike Share Program

Update on Regional Electric Bike Share Program

Evolve presented a proposal to expand its shared mobility program by introducing e-scooters alongside e-bikes, including three new parking zones in Comox and a broader regional rollout. The plan emphasizes safety, education, and responsible riding, with enforcement policies, community engagement, and launch targeted for summer 2025. They are requesting support from the Town of Comox to include electric scooters as part of the regional electric bike share program.

d. Ted & Laurie Winstone, 400 Davis Street - Notice on Title Recommendation

The delegation shared background leading to staff's recommendation for a notice on title for their property, raising concerns about the handling of a Stop Work Order for their portable shelter, including incorrect details and the lack of follow-up to their formal complaint.

e. Deb & Nels Nielson, 867 Labrador Drive - Notice on Title Recommendation

The delegation shared background leading to staff's recommendation for a notice on title for their property, expressing frustration with unclear documentation requirements. They noted that their letter to the Town, which outlined efforts to resolve the issues and proposed a discussion toward a fair resolution, received no response.

f. Jenny & Aric Nevalainen, 1638 Robb Avenue - Notice on Title Recommendation

The delegation shared background leading to staff's recommendation for a notice on title for their property, noting that their engineer passed away near the end of the project and that other engineers were reluctant to take over the work. They indicated the project would have been completed by now under normal circumstances and requested that Council not proceed with placing a notice on title.

They believe the lack of clear guidance has led to ongoing issues and feel they are being unfairly treated.
